On August 26, 2020, Trans Mountain provided an update on engagement with residents and interested parties (Engagement Update No. 1) [C08048].

Since these filings, Trans Mountain has continued engagement with local residents and provides the following engagement update to the filings, specifically to address Condition 60 g).

# Engagement Update 2 September 10, 2020

#### Overview

Trans Mountain has and will continue to share information and engage with residents of the Laidlaw and Popkum communities since the last Engagement Update filed on 26 August 2020. A summary of these activities is provided in this Engagement Update 2.

Shxw'ōwhámél First Nation, at their own discretion and independently from Trans Mountain, working with their local developer, cleared, graded and developed the 20-acre site as part of a long-term development by Shxw'ōwhámél First Nation for the community. In July 2020, Trans Mountain entered into a commercial agreement as a tenant, or occupant of the site.

The Popkum Construction Yard is owned and is being developed by Popkum First Nation. If approved by the CER, Trans Mountain will be a temporary occupant of the site during construction of the Expansion Project. Office facilities, a construction yard for storage of equipment, pipe, and other construction material will be located at this site for the duration of construction in the Coguihalla - Hope region.

## TMEP Landowner Agreements

The Trans Mountain Land Team has signed agreements with all the Trans Mountain Expansion Project (TMEP) landowners in the Laidlaw community, except for one resident, who is in agreement but lives out-of-country, and so finalization and signature of the agreement is delayed.

### Laidlaw Road - TMEP. Industrial and Public Use

Trans Mountain, its contractors and Shxw'ōwhámél First Nation have directed all workers to use the Highway #1 exit closest to each of the temporary worksites on Laidlaw Road. As a result, Project-related traffic will not travel on Laidlaw Road between the two exits, minimizing impacts to local residents. These exits, and the relative location of the temporary worksites, are indicated on Map 1.

- Laidlaw Stockpile Site: Project-related traffic will use Exit 153: Laidlaw Road
- Ohamil Camp Community: Project-related traffic will use Exit 160: Hunter Creek Road

Trans Mountain is aware there are other industrial and light traffic users of Laidlaw Road. Other road users include, but are not limited to:

- Logging trucks
- Gravel pit blasting and trucking, in proximity to the proposed Ohamil Camp Community
- Industrial dairy farm transport vehicles
- Transport trucks seeking to bypass Highway 1 weigh scales
- Light vehicles using Laidlaw road to avoid Highway delays

Shxw'ōwhámél LandSea Limited Corporation (SLLP), the Ohamil Camp Community contractor tracks construction traffic through GPS recorders.



# **Information Package Distribution**

The information packages described in Engagement Update 1 [C08048] were delivered by different methods to the following groups:

- Local Indigenous Communities: Electronic distribution
- Local, provincial and federal elected officials: Electronic distribution
- Fraser Valley Regional District (FVRD): Electronic distribution
- 40 residences in Laidlaw community, including all residences that could be located along Laidlaw Road, Fancher Road, MacKay Road, and Hunter Creek Road. The packages were either handed to the resident or placed at the door or in the mailbox.
- 4 residences in Popkum area: Included all residences on Yale Road East which is a dead-end road. The packages were either handed to the resident or placed at the door or in the mailbox.

In addition, the information package has been made available to the public on the Trans Mountain website at www.transmountain.com/ohamil.

Discussion regarding the distribution of the information package and an overview of the temporary worksites on Laidlaw Road was provided to key stakeholders on August 25, 2020 through a Spread 5B Monthly Construction Update meeting. Attendees included local governments, first responders, economic development organizations and elected officials. No new issues were identified during this meeting. The next meeting is planned for September 22, 2020.

## **Response to Invitation to Meet**

The information packages included an invitation by Trans Mountain to meet with individual residents either in-person, by phone or through a virtual platform. Meetings with individual residents is consistent with Trans Mountain's approach of addressing unique concerns of potentially affected residents.

As of September 10, 2020, Trans Mountain has not received any requests from residents to meet with Trans Mountain representatives. No new issues or concerns were identified during the hand delivery of the information packages to residents. Packages were left for residents who were not home during delivery. One elected official responded to say he had not received any inquiries or communications related to the temporary worksites on Laidlaw Road.

#### **Additional Outreach**

Despite the lack of response to Trans Mountain's invitation to meet, team members have continued engagement with Laidlaw residents. Since the delivery of the information packages, Trans Mountain has been in communication with four residents, understood to be members of the Laidlaw Community Association, as described by CAEPLA. As stated previously, Trans Mountain has no previous awareness of this Association and had been directed by the FVRD to communicate with individual residents.

The form of outreach, issues identified, and Trans Mountain's response are described in Table 1. For consistency, the identifier numbers assigned to each resident are consistent with



Engagement Update No. 1 [C08048]. The approximate location of the home of each resident is shown in the attached map.

## **Identified Issues and Trans Mountain's Response**

Trans Mountain continues to work closely with SLLP to identify and address concerns about the occupancy of the proposed Ohamil Camp Community and with Clearstream Energy Services (Clearstream) regarding concerns about the ongoing use of the Laidlaw Stockpile Site (HOP052). A response to urgent concerns will be provided within 24 hours of identification.
