Dear Prime Minister and Deputy Prime Minister and Minister of Finance:

Subject: Guaranteed Livable Basic Income

On behalf of Shining Waters Regional Council, I am writing to urge the Canadian Government to create a Guaranteed Livable Basic Income for all Canadians over the age of 18 years old that accounts for regional variations in the cost of living, and does not require participation in the labour market for eligibility.

As you begin your National Convention, we are hopeful and optimistic that consideration will be given to this important and necessary program that will protect Canadians. With the growing momentum in support of this initiative by Canadians of all political persuasions, including many Senators and MPs, the time is right to take steps toward implementing a Guaranteed Livable Income.

Poverty can happen very quickly to anyone. A guaranteed livable income would help address the persistent inequities within our country.

The United Church of Canada has actively advocated for a Universal Basic Income (Guaranteed Annual Income) since 1972, seeing it as a means of ensuring financial security for all people, while being more equitable and less costly than the myriad of provincial and government support programs currently in existence. Since then, national and international studies have shown that Universal Basic Income is both affordable and has beneficial effects in the areas of health, justice, education, and social welfare. As a church, we advocate for a Universal Basic Income because following Jesus' example means believing in the inherent value of all people — regardless of the spiritual and economic circumstances in which they find themselves.

Poverty is never the fault of the poor.

Over and over again, we see the effects of poverty disproportionately affecting Indigenous peoples, racialized peoples, women, those who live with mental illness and physical disability. A
