Subject: Woodfibre Liquefied Natural Gas and FortisBC/Eagle Mountain Pipeline Projects Update

1. Objective:

To summarize project-related activities for the FortisBC Eagle Mountain (EGP) – Woodfibre Gas projects (WLNG) from October through November 2023:

- To review timelines for both projects, including any changes since the prior update period.
- To summarize project-related activities for the EGP –WLNG that took place October through November 2023.
- To look ahead at anticipated activities for the months of December 2023 and January 2024.
- To review District capacity impacts.

Coordinated	 Staff will continue to provide project oversight for the District and engage with FortisBC and WLNG staff in joint monthly Technical Working Group meetings. The Technical Working Group is modifying its Terms of Reference to include technical, project impacts, and issues management discussions. Staff will continue to work with other project regulators to coordinate regulatory processes and compliance-related activities.

5. District Capacity Impacts:

➤ The District's 2024-2028 financial plan included capacity funding from FortisBC and Woodfibre LNG to support the creation of a new project department, Major Projects − Industrial, to administer regulatory requirements, interface with project proponents and



- regulators, and support District communications efforts and community resiliency planning for the EGP and WLNG Construction Projects.
- > This new department will ensure that existing District priorities and current workstreams are not impacted by either Project and that the District maintains its commitments and legislated requirements to provide equitable service levels for all businesses and residents.
- ➤ The District is currently in the process of setting up related operations and processes, including related staffing.
