Please describe how the nominee demonstrates resilience and leadership in one of the following ways:

- advocating for positive changes at the regional, national and/or international level for patients and/or physicians with disabilities
- encouraging and facilitating the development of more equitable supports (e.g., facilities, assistance or funding) for patients and/or physicians with disabilities

- · advancing the humanitarian or cultural life of his or her community
- · improving medical service in Canada

Such lifetime achievement should be so outstanding as to serve as an inspiration and a challenge to the medical profession in Canada.

#### John McCrae Memorial Medal

Please describe how the nominee has demonstrated traits such as compassion, self-sacrifice or innovation beyond the call of duty that have greatly benefited the health or welfare of fellow military personnel or civilian populations.

## May Cohen Award for Women Mentors

Please describe how the mentor has demonstrated outstanding mentoring abilities beyond normal professional duties by:

- encouraging, facilitating and supporting mentees in career and leadership development
- · acting as an effective role model in medicine or medical leadership
